Mix 1 part DIP'N GROW to 5 parts water.

**MEDIUM HARDWOOD CUTTINGS:**  
Mix 1 part DIP'N GROW to 10 parts water.

**SOFT WOOD CUTTINGS & SUCCULENTS:**  
Mix 1 part DIP'N GROW to 20 parts water.

Dip basal end of cuttings only, individually or in bunches, for 3 to 5 seconds. Following dipping, immediately place cuttings into planting media.
